With reference to the subject cited, vigilance and enforcement department has inspected some NWHs in Nalgonda district and noticed some deficiencies and made following recommendations


1. To ensure that Net Work hospital (NWH) shall issue 10 days post-discharge medication and counsel the patient for follow-up at the time of patient discharge.
2. Network Aarogyamithras (NAM) has to facilitate cashless transaction at hospital and collect the feedback from the patient and follow-up about the recovery of patient.
3. Every Hospital has to be equipped with multipara-monitors, defibrillators, crash carts, resuscitation equipment, central oxygen & suction facilities and attached toilet facility.
4. Every Hospital has to maintain the Essential drugs which should be available in the Pharmacy round the clock and also maintain 9 duty doctors along with adequate number of nursing staff, helpers, administrative and maintenance staff.
5. Every Hospital has to maintain a minimum 50 bed strength which is empanelled under the Aarogyasri scheme as under
  - a) Hospital casualty ward must have 5% of total bed strength subject to minimum of three bedded emergency department.
  - b) ICU must have at least 10% of total bed strength subject to minimum of five beds.
  - c) Post operative ward must have at least 5% of total bed strength subject to minimum of three beds.
6. It is decided to impose penalty on NWHs as mentioned below for infrastructure, equipment and man power deficiencies:

S.No.	Penalty proposed for violation (beds found are less than 50)	Penalty amount proposed for violation for first time	Penalty amount proposed for violation for second time
1	If the number of beds found less than the 25% of total 50 beds	Rs. 25,000/-	Rs.1,00,000/-
2	If the number of beds found less than the 50% of total 50 beds	Rs.50,000/-	Rs.2,00,000/-
3	If the number of beds found less than the 75% of total 50 beds	Rs.1,00,000/-	Rs.4,00,000/-

❖ If the NWH deviates for the third time the hospital will be de-listed from Aarogyasri and other Schemes.

Hence, all the Network hospitals are hereby informed to make a note of the above recommendations and to take immediate action for implementation of above recommendations.
